

## Surrey Record Society

The Society exists to publish records relating to the historic county of Surrey, including the parishes of South London as far east as Rotherhithe. Founded in 1913, it has printed transcripts, translations and abstracts of texts ranging in date from the 12th to the 20th century, and in subject from central, county and municipal government to ecclesiastical, manorial, industrial and military history. Each text is provided with a general introduction and indexes. Through the Society's work manuscript sources held in repositories in and outside the county have been made readily accessible to students of Surrey's history and family historians.

### Membership

Individuals and institutions are eligible for membership at an annual subscription of £5 (**increasing to £10 in January 2025**). Members receive any volume published in a year for which they have paid a subscription and pay reduced prices for earlier volumes.
