Twelve15 offers a traded catering service to schools to enable them to meet their statutory obligation of providing free school meals.

The contractual agreement/SLA in place with schools, includes an annual uplift of the paid meal price for Key Stage 2 (KST2) pupils who are not eligible to a means tested free school meal. The price review is applicable each September for the life of the arrangement. The next uplift is due in September 2025 when the price of a paid meal is subject to a ten pence uplift, taking the price for a paying customer from £2.80 to £2.90.

The price review forms a key element of the Twelve15 2025/26 budget as offset to the inflation pressures in the cost of service delivery.

The impact of the price review will only affect those customers who pay for a school meal. This group sits in the Key Stage 2 cohort of pupils aged between 7 to 11 years old. The price increase may impact affordability for some families whose children may not be eligible to a free school meal particularly at a time of cost-of-living pressures.

This assessment considers if the price review for September 2025 disproportionately impacts pupils in KST2 with protected characteristics or who are from an identifiable vulnerable group.

There is no impact to Twelve15 staff as a consequence of the price uplift.



The provision of free school meals to all pupils in KST1 and means tested in KST2, seeks to ensure that access is made available to many of those identified in the groups above. Twelve15 will continue to work closely with schools to promote access to families eligible to free school meals wherever possible to mitigate the identified negative impacts.
