

Copy of the OS Second Edition 1897 1:2500 map Surrey Sheet XXXVII.8. updated to 1912 for Inland Revenue purposes. The application route (a White Road) is highlighted in yellow.

I ~~We~~ attach copies of the following documentary evidence [~~including statements of witnesses~~] in support of this application:-

- Extract from 1857 Elstead Inclosure Awards (Page 4) describing the allotment of land of 30ft width for Public Driftway or Heath Road 25 (the road) along this route, (highlighted in turquoise in margins). The road is defined as running from Point M to Point N on the Inclosure Map.
- Extracts (overlapping) from the 1857 Elstead Inclosure Awards Map showing the route of Public Driftway or Heath Road 25, (numbered DW 25 MAP 1, 2, 3, 4 and 4a). The road is near the centre of maps DW 25 MAP 1 and 2 and the driftway number (25) is visible in the centre of the track approx. 4" from the top of MAP 1 and 0.75" from the top of MAP 2.
- The route which is the subject of the application is covered by maps DW 25 MAP 1 and 2. Maps DW25 MAP3, 4 and 4a are included to show the location of Point N mentioned above.
- Point M is on bridleway 99. Point N is on bridleway 77 which is not included in this application.
 - (The Elstead Inclosure Awards are stored at the Surrey History Centre under reference QS6/4/58).
- Plan of the Surrey Commons Military Lands Area (the map attached to the 1978 Surrey Commons Military Lands Byelaws) showing that the road is excluded from that land on Hankley Common and Houndown which is controlled by the Secretary of State for Defence. The road is highlighted in turquoise.
- For information, map from SCC Rights of Way web site showing bridleway 99 running along Houndown Bottom.
