Amendments to Waiting and Loading Restrictions
And On-Street Parking Places in the Borough of Epsom and Ewell

Surrey County Council propose to make “The Surrey County Council (Various Roads in Epsom and Ewell) Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.9) Order 202-” The purpose and effect of the Order will be to make certain amendments to the waiting and parking restrictions in the Borough of Epsom and Ewell under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 36, 45, 46, 49, 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) as follows:-

- (1) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2018” so as to: -
 - (a) prohibit waiting by vehicles in certain lengths of the roads specified in the First Schedule to this Notice, on the days and at the times indicated in the said Schedule;
Exemptions for loading on and unloading from vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the First Schedule, the maintenance of those roads and the services in them and for disabled persons’ vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions;
 - (b) provide that exemptions for loading on and unloading from vehicles, boarding, and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the First Schedule, the maintenance of those roads and the services in them and for disabled persons’ vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions;
 - (c) prohibit the waiting by vehicles for the purpose of loading on and unloading from vehicles in certain lengths of the roads specified in the First Schedule to this Notice, subject to the exemptions specified in sub-paragraph (b) above, save that the exemption for Blue Badge holders will not apply;
 - (d) amend the existing waiting restrictions in certain lengths of roads specified in the First Schedule to this Notice to be operational on the days and at the times indicated in the said Schedule.

- (e) revoke the existing waiting restrictions in certain lengths of the roads specified in Part I of the Third Schedule to this notice, during the times and on the days specified in the said Schedule, without replacement.
 - (f) extend the hours of the current waiting restrictions in a certain length of the western side of Hylands Road, Epsom as specified in the First Schedule to this Notice
- (2) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2018” so as to: -
- (a) prohibit the stopping of vehicles outside schools, as indicated by zig-zag markings on site, in certain lengths of White Horse Drive, Epsom, applying Monday to Friday (inclusive) between 8.15am and 9.15am and between 2.30pm and 4pm. The usual exemptions shall apply, namely any person causing a vehicle to stop in order to avoid an accident if required to do so by law; anything done with the permission of a police constable in uniform or in accordance with a sign placed by Surrey Police in accordance with Section 66 or 67 of the Act; or any vehicle which is displaying a valid waiver certificate issued by the Council;
 - (b) carry out legal drafting amendments to the Order to match the existing restrictions on the ground.
- (3) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2018” so as to: -
- (a) provide a disabled persons’ free on-street parking places in a certain length of the road specified in the Second Schedule to this Notice to operate at the times and on the days specified therein;
 - (b) revoke the existing disabled persons’ free on-street parking places in the lengths of road specified in Part II of the Third Schedule to this Notice without replacement
 - (c) provide that certain other vehicles may wait in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (20 minutes), etc;
- (4) Amend “The Surrey County Council Various Roads in the Borough of Epsom and Ewell (Consolidation of Permit Holder Only) (On-Street Parking Places) Order 2018” so as to: -
- (a) impose a resident only parking scheme in a certain length of the eastern side of Hylands Road, Epsom with the letter identifier “GG” to operate Monday to Friday (inclusive) 9am to 5pm. The residents that may be eligible to apply for parking

permits will be all residents of Hylands Road, Epsom. The following provisions will apply: -

- (i) the vehicles which may be left in the parking place, during the hours of operation shall be vehicles displaying a valid parking permit bearing the appropriate identifying letter;
 - (ii) provide residents' parking permits for residents of the said properties, which will allow them to park in the said on-street permit holders' only parking place during the hours of operation. Such permits will cost £80 for the first permit, £100 for a second permit and £130 for any subsequent permit (as applicable) and will be valid for a period of twelve months. These charges will rise by £4 on the 1st of January on each of 2024, 2026, and 2028. The charge for a duplicate permit or a change of permit due to the change of vehicle will be £15;
 - (iii) provide that such residents parking permits shall be allocated using the following calculation: the sum of the number of vehicles registered to the place of abode minus the number of off-street parking places for such place of abode;
 - (iv) provide for: (1) residents to purchase permits for use by their visitors at a cost of £2 each, which will be valid for one day, subject to a limit of 150 pa, or £1 which will be valid for 2 hours limited to 250 pa; (2) Operational Permits, for use by doctors and nurses, and Carers Permits, for carers and community care personnel who are required to make visits to residents, which will be free of charge; and (3) Child Care Permits, for persons employed to visit a resident for the purpose of child care, pursuant to a contract of employment, will incur the same cost as a resident's permit, dependant on how many permits the resident has already been issued
- (b) amend the hours of operation of the existing permit holders only on-street parking place in Woodstock Court, Epsom (letter identifier "O"), to operate at all times.
 - (c) amend the hours of operation of the existing permit holders only on-street parking place in Mill Lane, Ewell (letter identifier "S"), to operate Monday to Saturday (inclusive) between 8.30am and 6.30pm
 - (d) replace a length of "single yellow line" restriction with three permit holder's only on-street parking places in a certain length of Worple Road, Epsom (letter identifier "D"), to operate Monday to Saturday (inclusive) between 8.30am and 7pm.
 - (e) Include the residents of No.7 and No.7A Ashley Road, Epsom to be eligible for permits in Permit Parking Zone "G". The costs and conditions of use will be the same as in sub-paragraphs (4)(a)(i) to (4)(a)(iv) above

- (5) amend “The Surrey County Council Hookfield and Lindsay Close Controlled Parking Zone in the Borough of Epsom and Ewell (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2018” so as to: -
 - (a) revoke the existing permit holders only restriction on the parking bays in Hookfield, Epsom replacing them with unrestricted parking bays
 - (b) withdraw the existing resident only parking scheme in Hookfield, Epsom and Lindsay Close, Epsom as the scheme has not been utilised
- (6) amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation of Free Street Parking Places and Revocation) Order 2018” so as to: -
 - (a) introduce a time limited parking bay in East Street, Epsom with the restriction of Monday to Saturday (inclusive) 8.30am to 6.30pm 20 minutes no return within 1 hour
 - (b) impose a time limited restriction to the existing parking bays in Glyn Close, Ewell to be operational Monday to Saturday (inclusive) 8.30am to 8.30pm 2 hours with no return within 1 hour
- (7) Make certain drafting amendments to the following existing Orders which impose waiting, loading and unloading and parking prohibitions and restrictions in the Borough of Woking, which will not affect the operation of those prohibitions and restrictions:-
 - (a) The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation of Free On-Street Loading Bays and Goods Vehicles’ Free On-Street Loading Bays) Order 2018
 - (b) The Surrey County Council (Various Roads in Epsom and Ewell) Electric Vehicle Parking Places Order 2023
 - (c) The Surrey County Council Various Roads in the Borough of Epsom and Ewell (On-Street Car Club Parking Places) Order 2023

Where a restriction is proposed herein any existing restriction on the same length of road will be revoked, unless otherwise indicated.
